 6. The bids shall be opened in the presence of bidder's representative who choose to attend at 14:00 Hrs, **19 August 2018** at the office of **Phungling Municipality, Taplejung**. Bids must valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format, amounting to a minimum of **NRs. 1,80,000/-** which shall be valid for **30 days** beyond the validity period of the bid.
 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
 8. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063, Public Procurement Regulations-2064 and their amendments.
